The first part of the eye exam is an assessment of acuity. This can be done with either a standard Snellen hanging wall chart read with the patient standing at a distance of 20 feet or a specially designed pocket card (held at 14 inches). Each eye is tested independently (i.e. one is covered while the other is used to read).
